In Today's Update:

- 1. <u>DfE</u>: Review of MAT regulation: advisory group membership and TofR, updated behaviour guidance for schools plus searching and confiscation guidance, updated suspension and exclusions guidance for schools, research with parents on EY and childcare, Ofsted revised inspection handbook for early years, evaluation of teacher assessed grades, NTP guidance for schools.
- 2. <u>National reports:</u> Report on shaping national plan for education, priorities for a fairer economy by 2030 illustrate future world of work for pupils.
- 3. Research: Mental health in schools: mindfulness little value as a whole school approach, but there are ways to identify schools with higher SEMH need. How difficult can it be to test the link between breastfeeding and intelligence? As it turns out: very! Early analysis of students and wave 1& 2 T-levels.
- 4. News: Survey of heads finds increasing difficulties when recruiting teachers, how schools assisted covid research, opposition amendments for Schools Bill, a deeper look at persistent absence data, new Schools Minister will also lead on SEND, regulator gives thumbs up to school league tables, shortage of school governors hits 6-year high.

1. DfE:

- Updated suspensions and exclusions guidance for schools. Headteachers can still rescind a PEx, all schools are required to inform LA of all suspensions without delay, and guidance for off-site directions and managed moves.

- Qualitative about parents' views about early years and childcare. Insights about how parents identify
 and select childcare and blocks in the system, for example for single parents.

- Ofsted has revised its handbook for early years settings for implementation from September. It reflects updates to the EYFS and has a separate section now for inspection of childminders. https://www.gov.uk/government/publications/early-years-inspection-handbook-eif
- Ofqual publishes its evaluation of the experience of teacher assessed grades (TAGs) last year (informed by a self-selection survey). Most teachers found the process stressful and were not keen to repeat. About half of students responded they felt TAGs were fair, but about a third did not feel wellprepared for the next stage of their learning.

2. National reports:

- The Foundation for Education Development's report about the future shape of education in England, based on consultations with the sector. The lack of long-term planning from Government and weaknesses at the middle tier are highlighted, together with education that is not sufficiently equipping young people for future needs, such as use of technology. https://fed.education/wp-content/uploads/2022/07/fed-national-consultation-report-2022.pdf
- Interim report about achieving a fairer economy in the UK by 2030, highlights how wide the divide continues to be between rich areas and poor: average incomes in the richest LA area (Kensington) are 4x those in the poorest (Nottingham). Due to changes in work patterns around 8 million young workers (under 30) have never worked in jobs with reliable annual wage rises.

3. Research:

- Large mental health study from the UK finds no evidence for additional benefits for secondary students of a whole-school mindfulness programme over-and-above the support routinely in place in school. There was too little use made by students of mindfulness as a result of the lessons.

- Early analysis of T-levels and student preparedness, based on the 2021 students and the four wave 1 and 2 T-level subjects. Overlap with other technical courses varied between 20% and 80% dependent on subject. To be T-level ready, a 4 or better at GCSE English and maths is seen as key and between 70% and 81% of students on equivalent technical courses did not have this.

- Summary of a survey from ASCL about teacher recruitment and retention. Nearly all respondents
 report difficulties recruiting to vacancies and over 70% are using supply teachers to cover vacancies.
