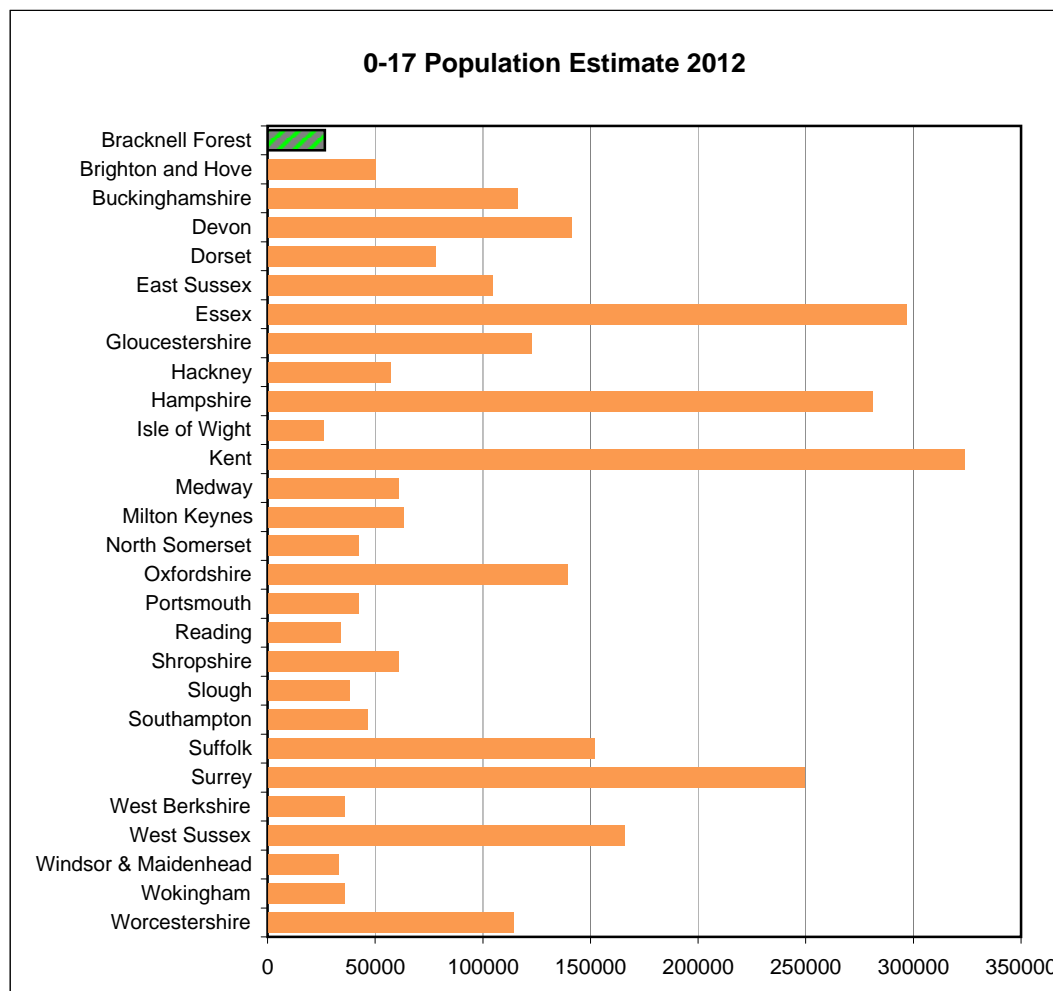
### Coverage

Actual vs. Expected Rate of Referrals 2013

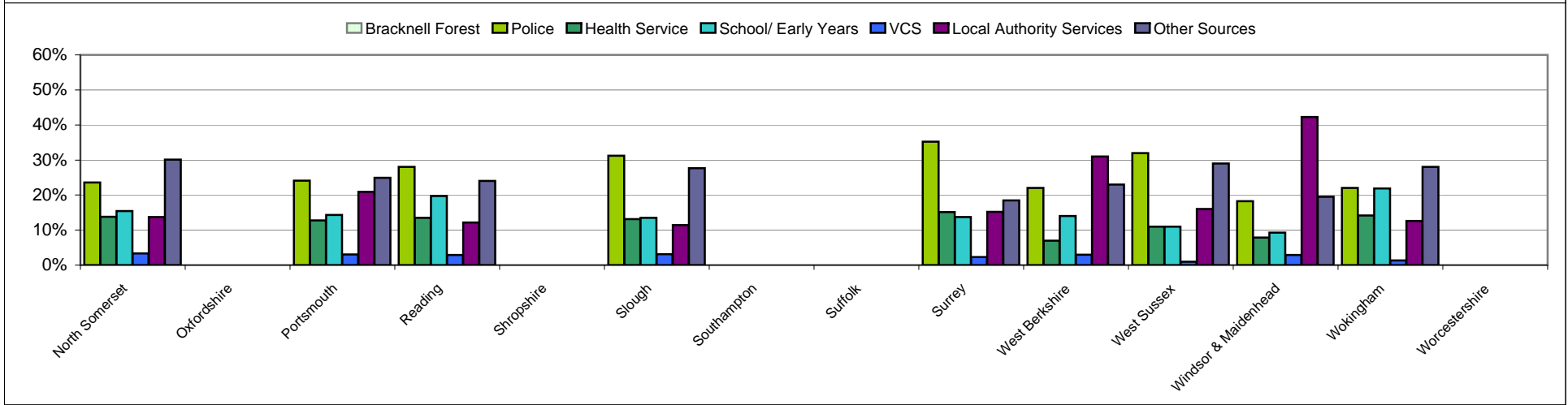
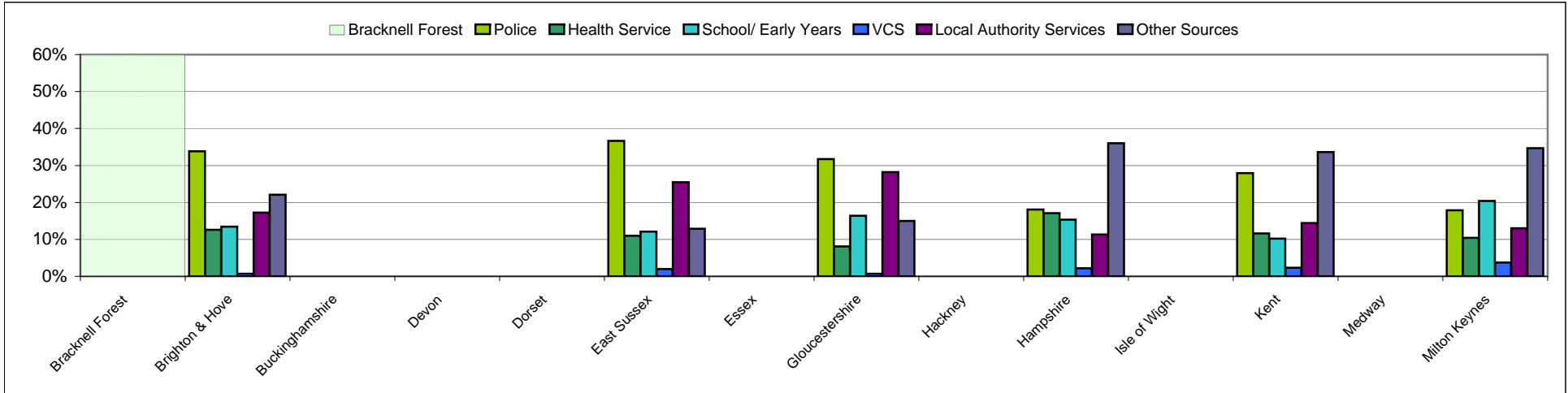

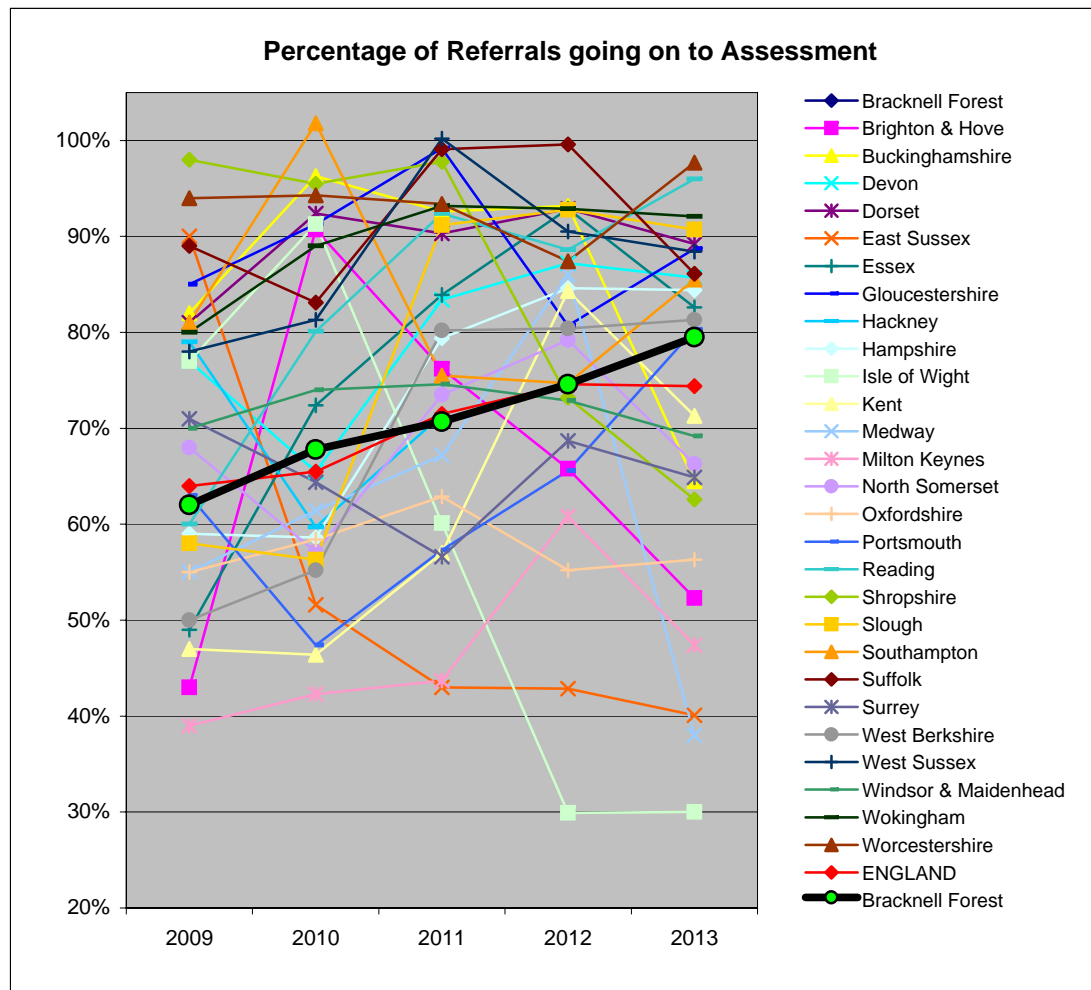

Percentage of Referrals to Social Care from Police/ Health/ Schools & Early Years/ LA Services/ VCS/ Other Sources (2012-13)



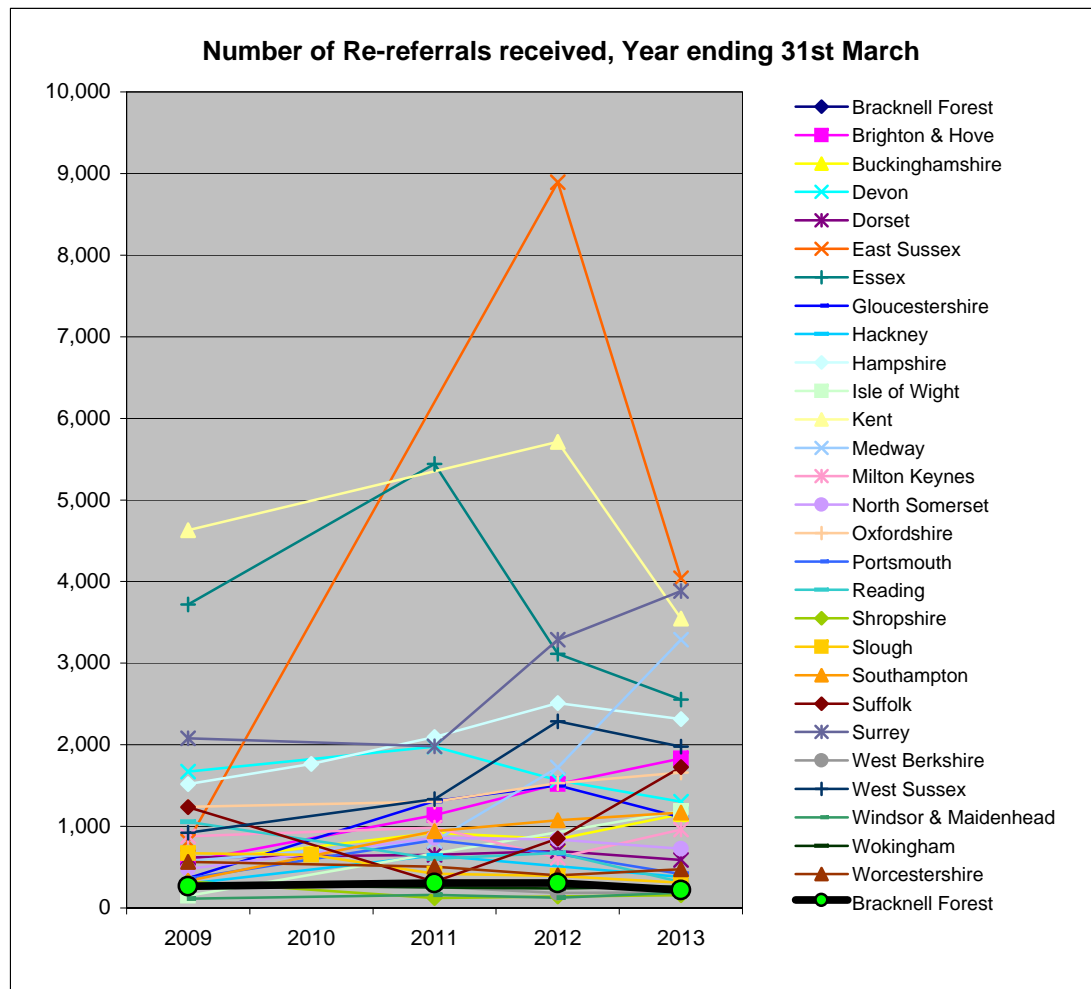

Actual vs. Expected Rate of Re-referrals 2013

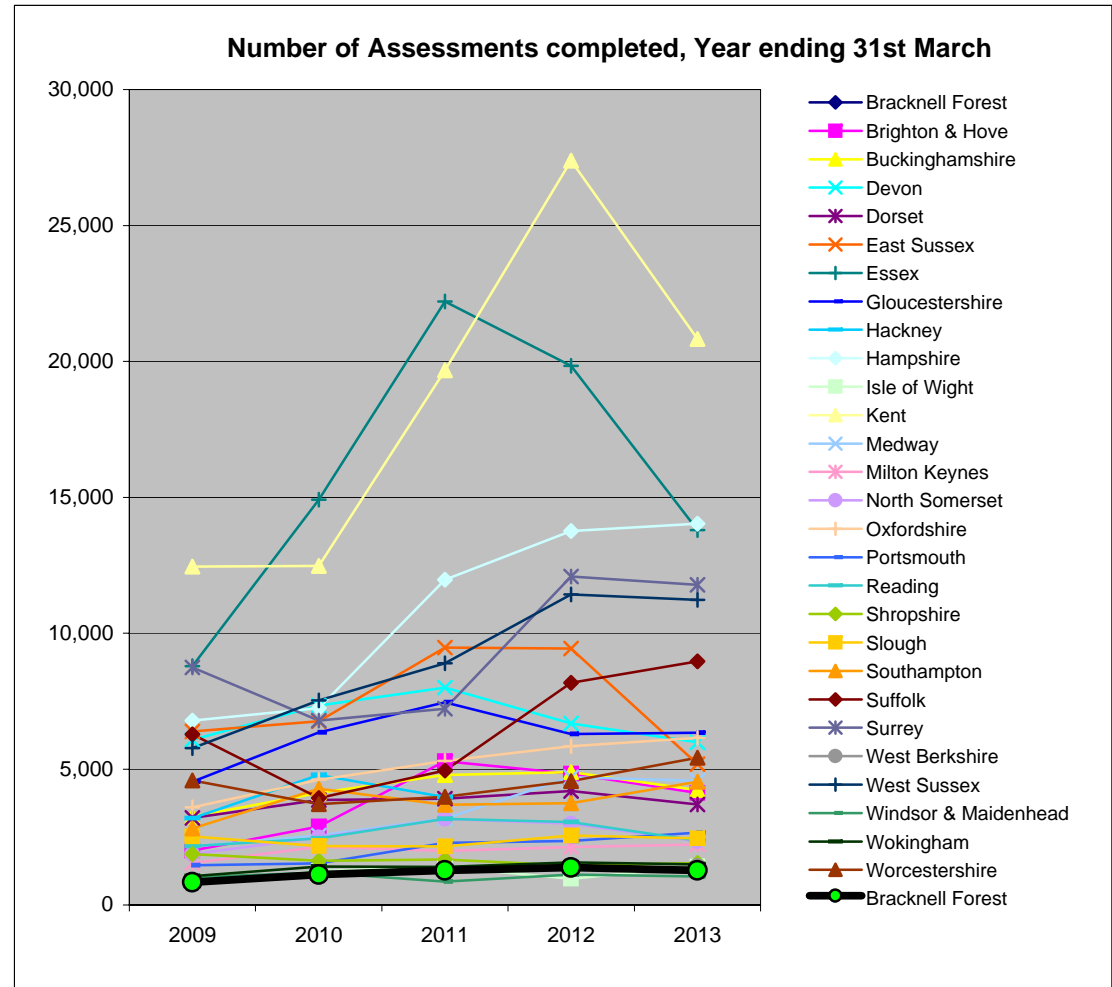

Rate of Children in Need, per 10,000 0-17 year olds

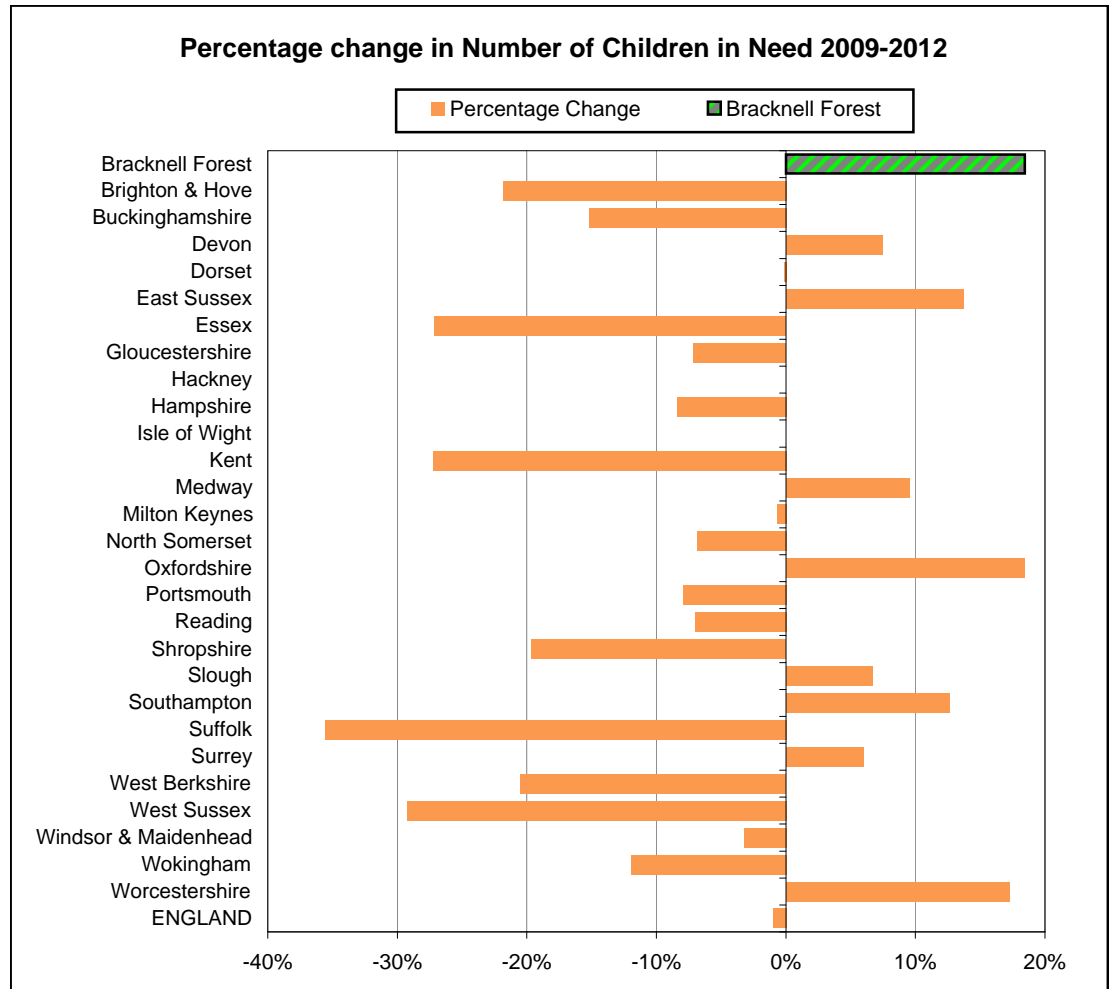

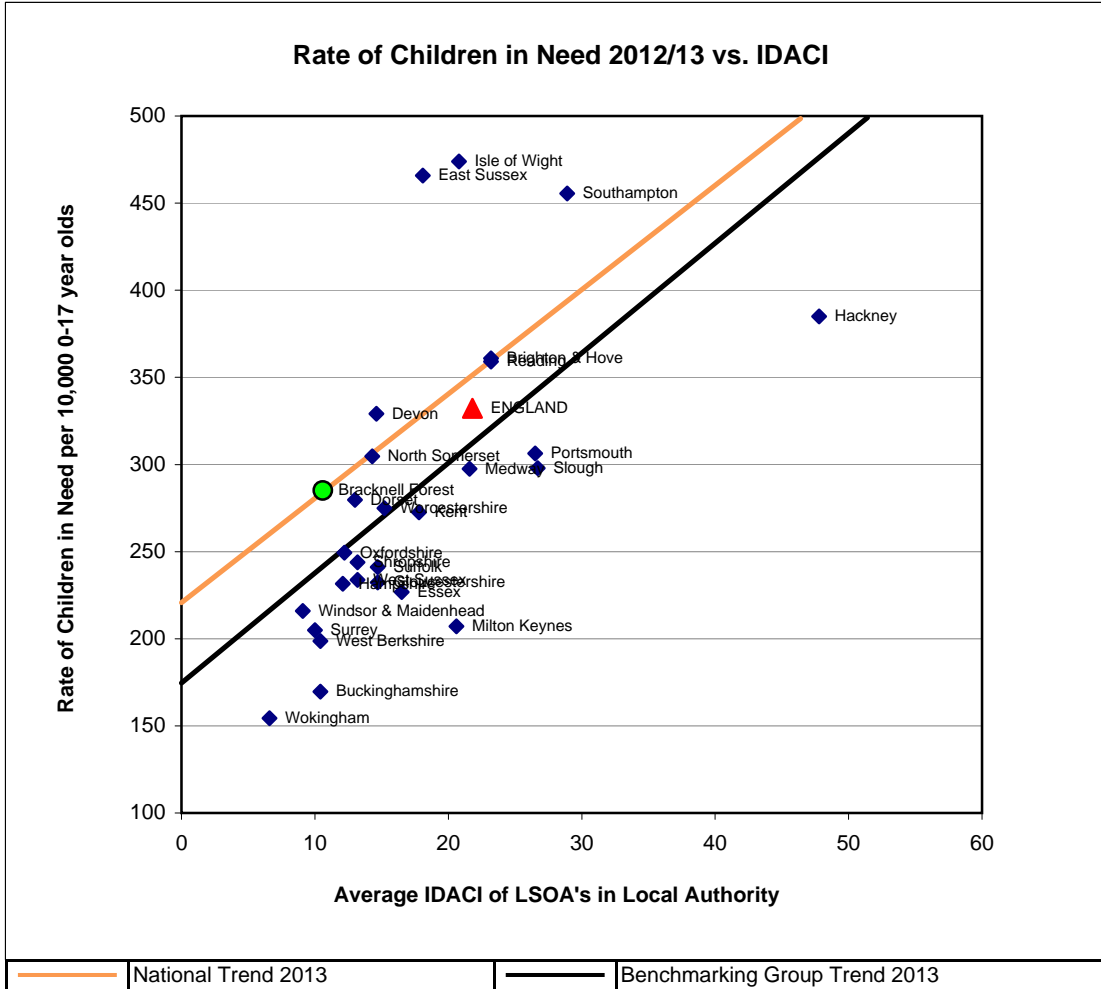

Percentage change in Number of Children in Need 2009-2012



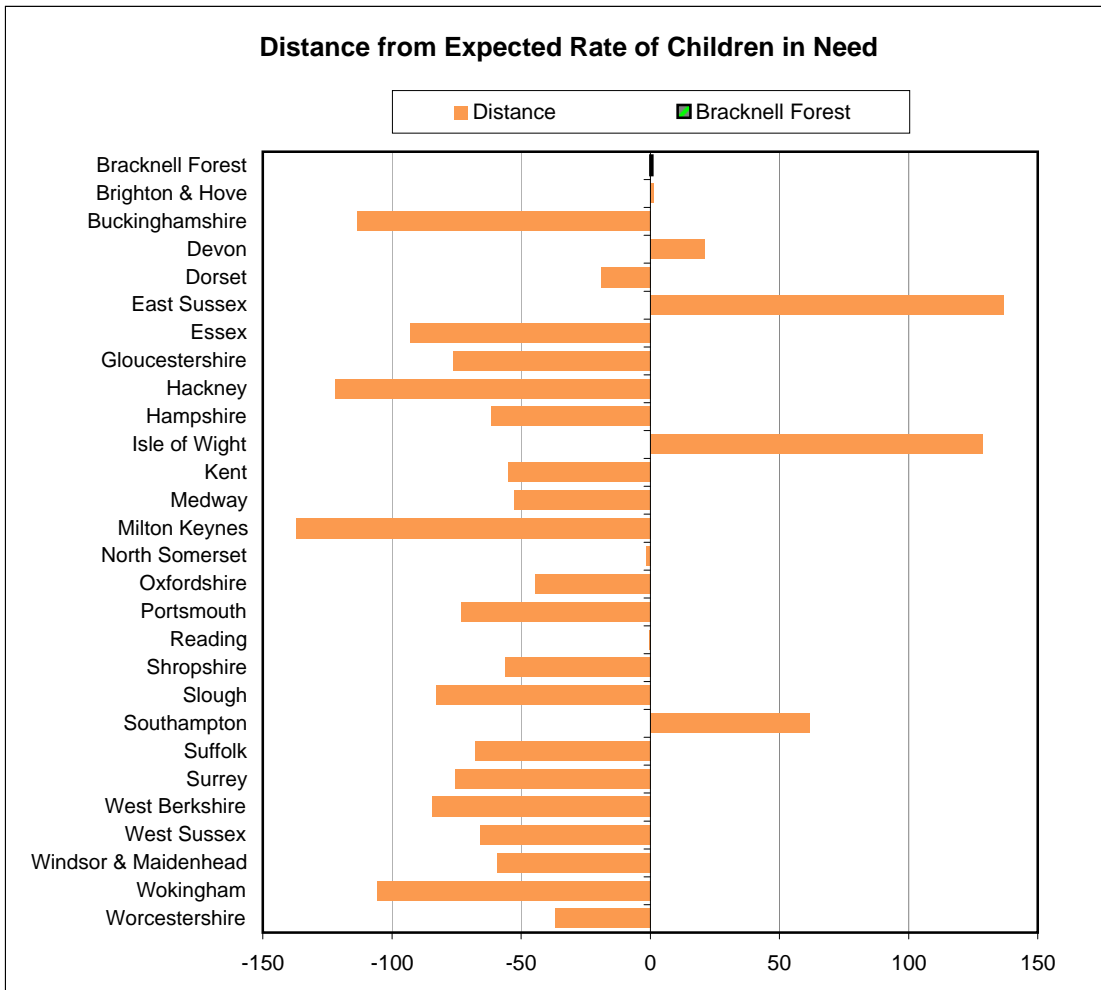

Percentage change in Number of S47 Enquiries 2010-2013



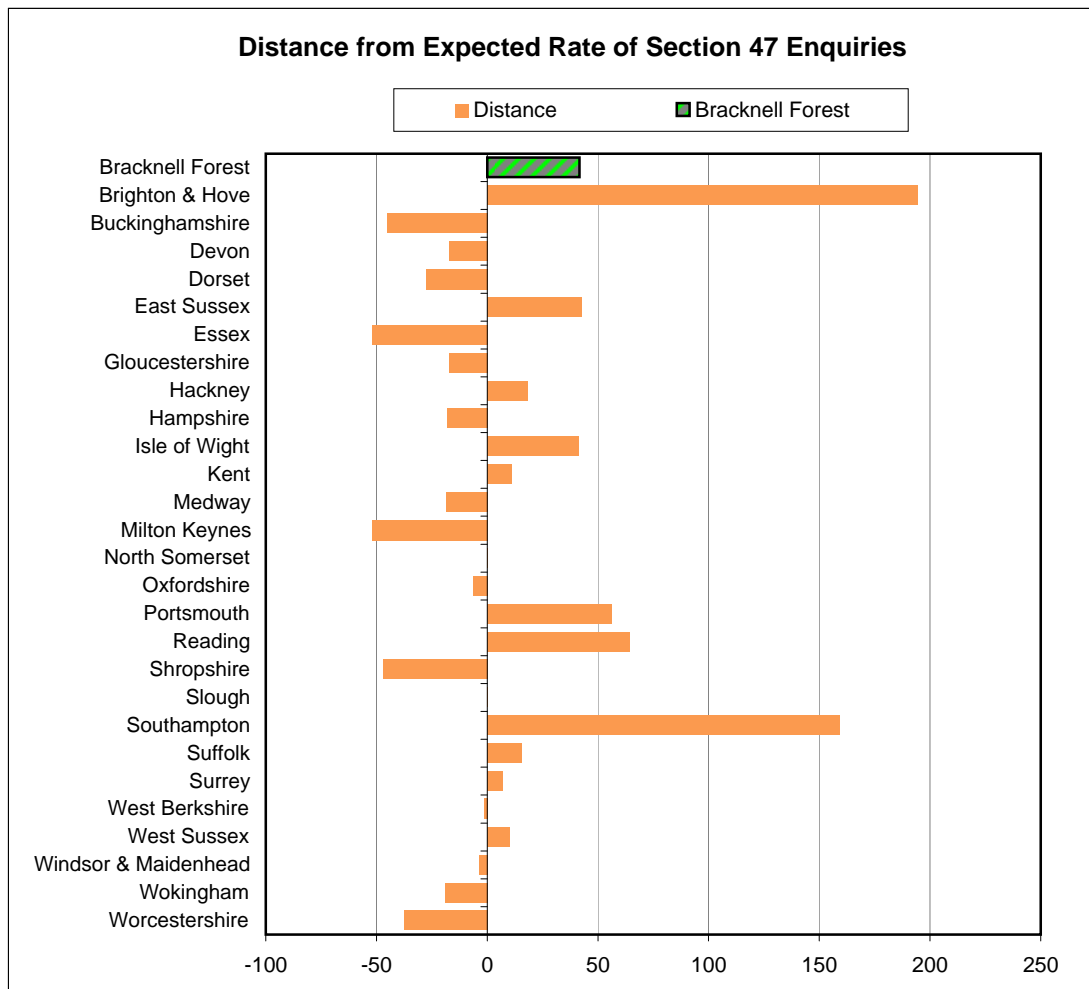

Number of Care Applications to Court, year ending 31st March

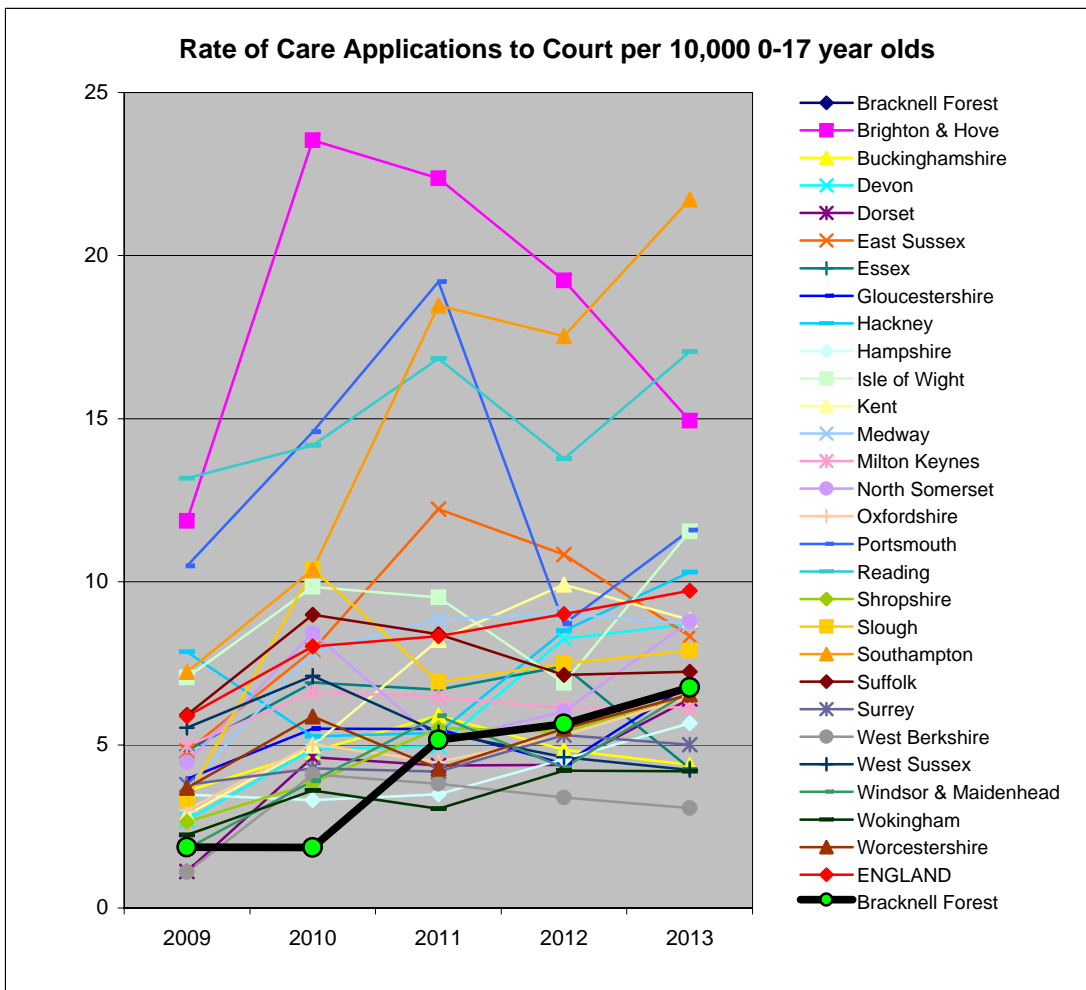

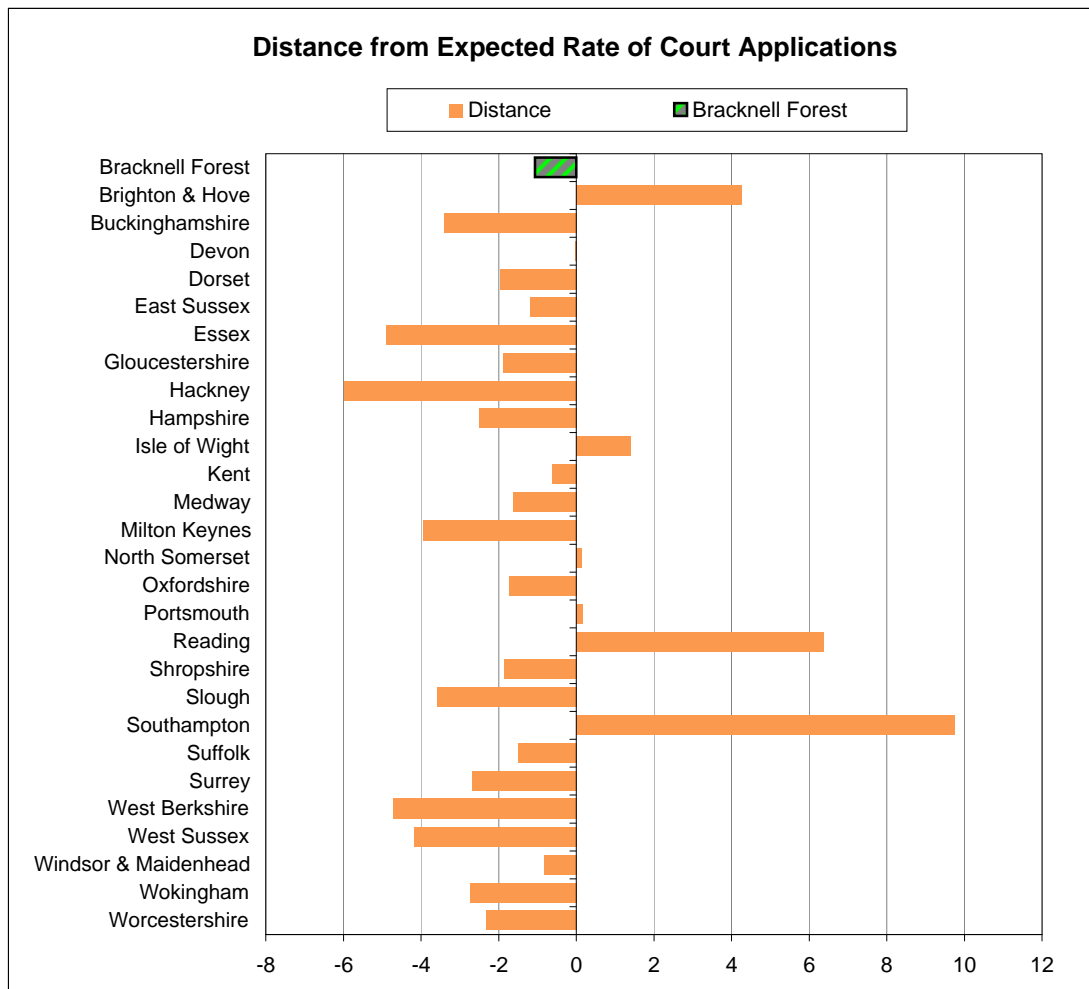

Actual vs. Expected Rate of Court Applications 2012

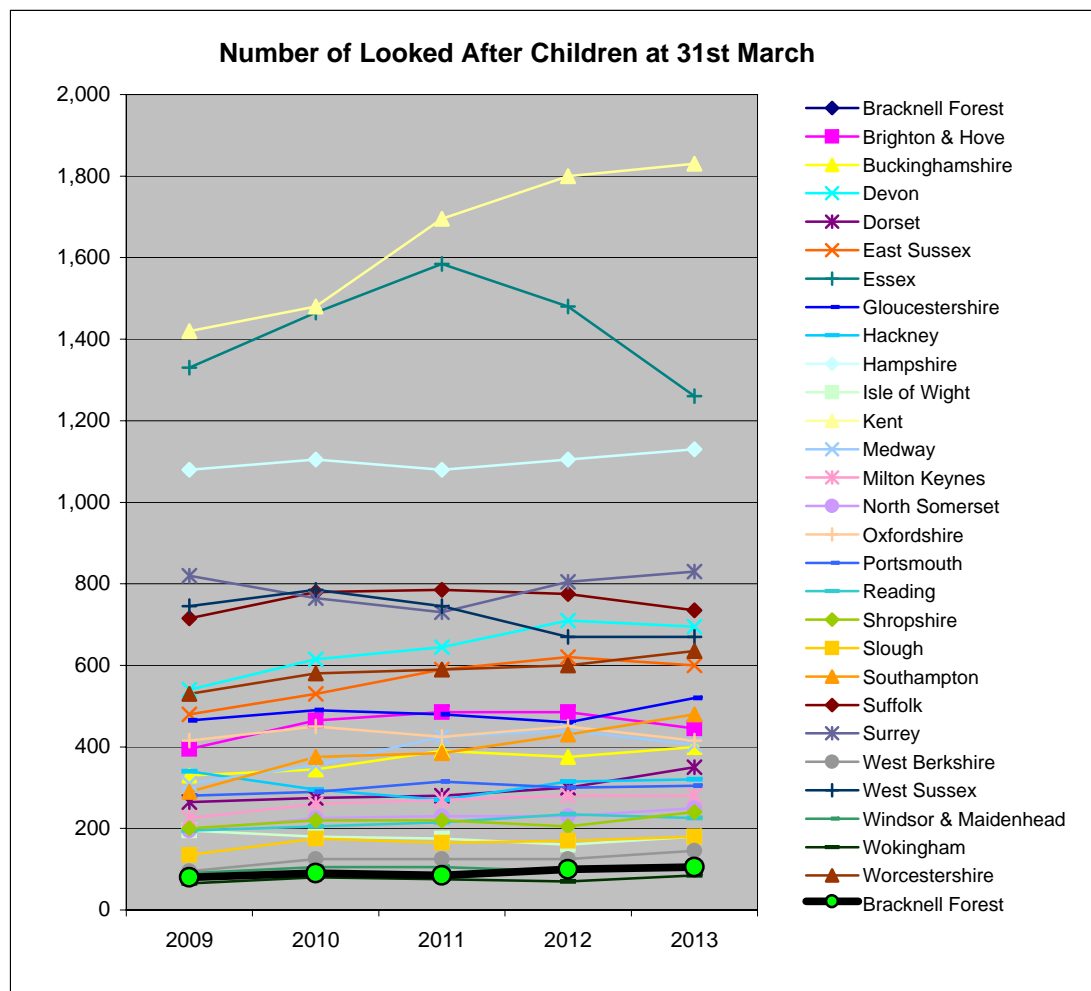

Actual vs. Expected Rate of Looked After Children 2013

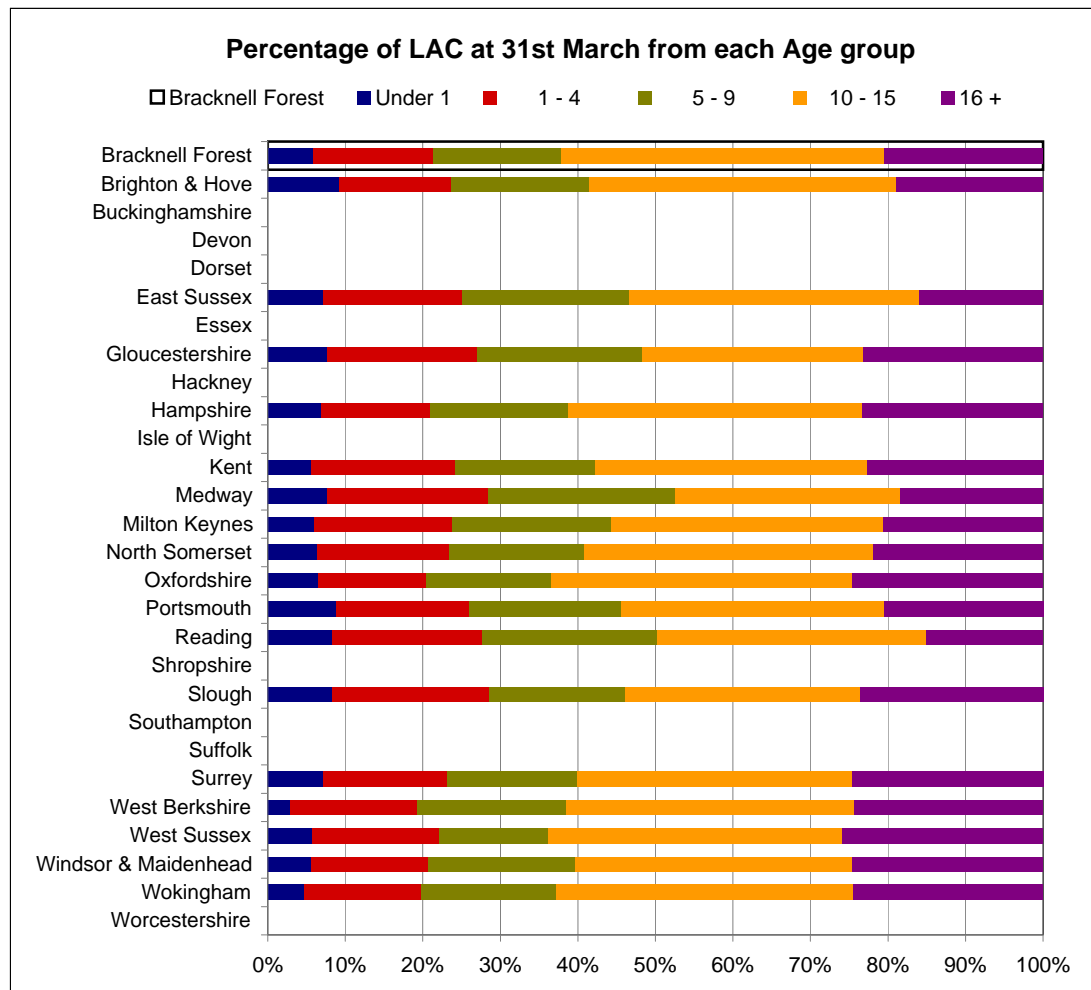

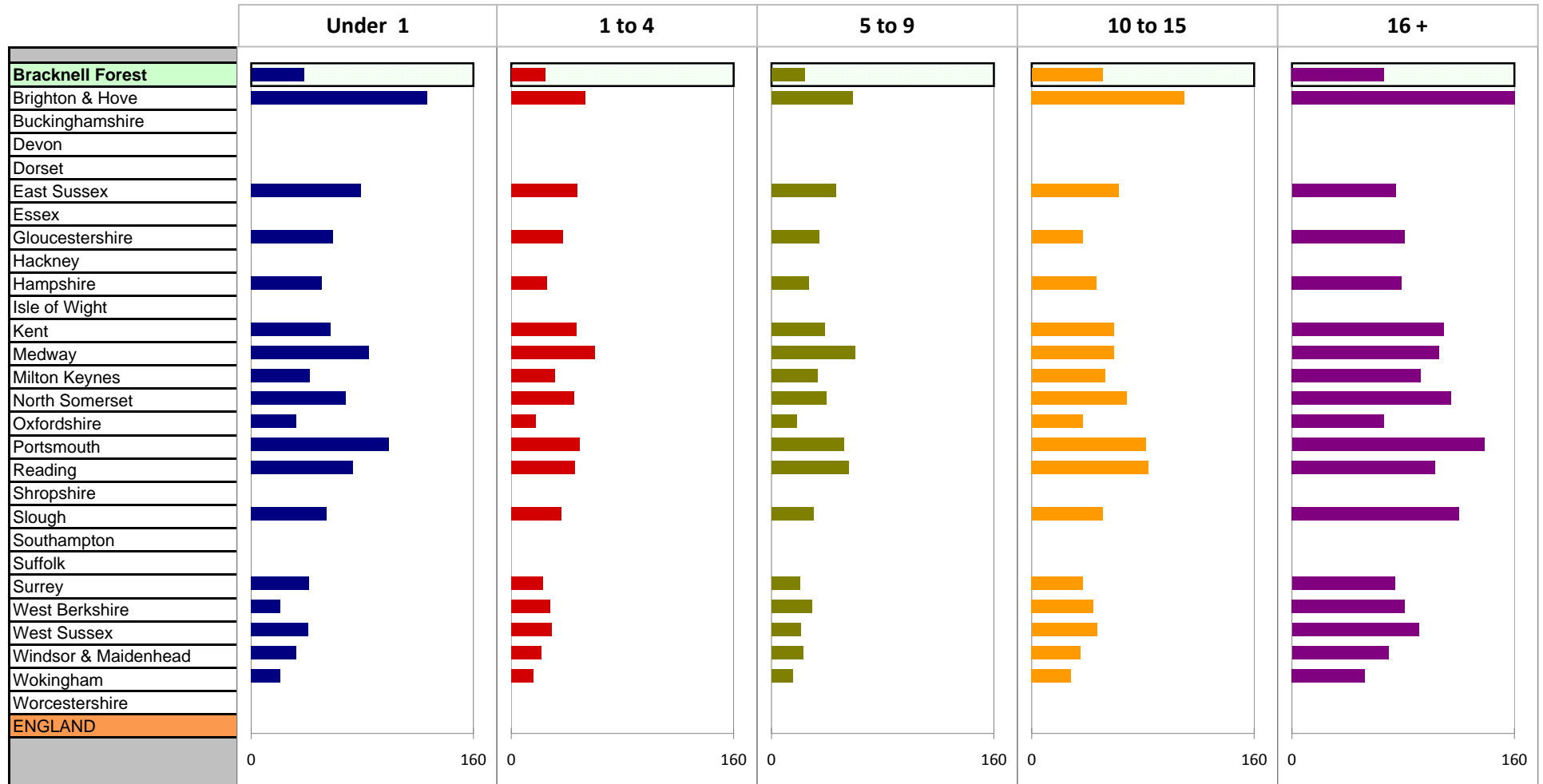

Rate per 10,000 of Children Looked After at 31st March, by Age group

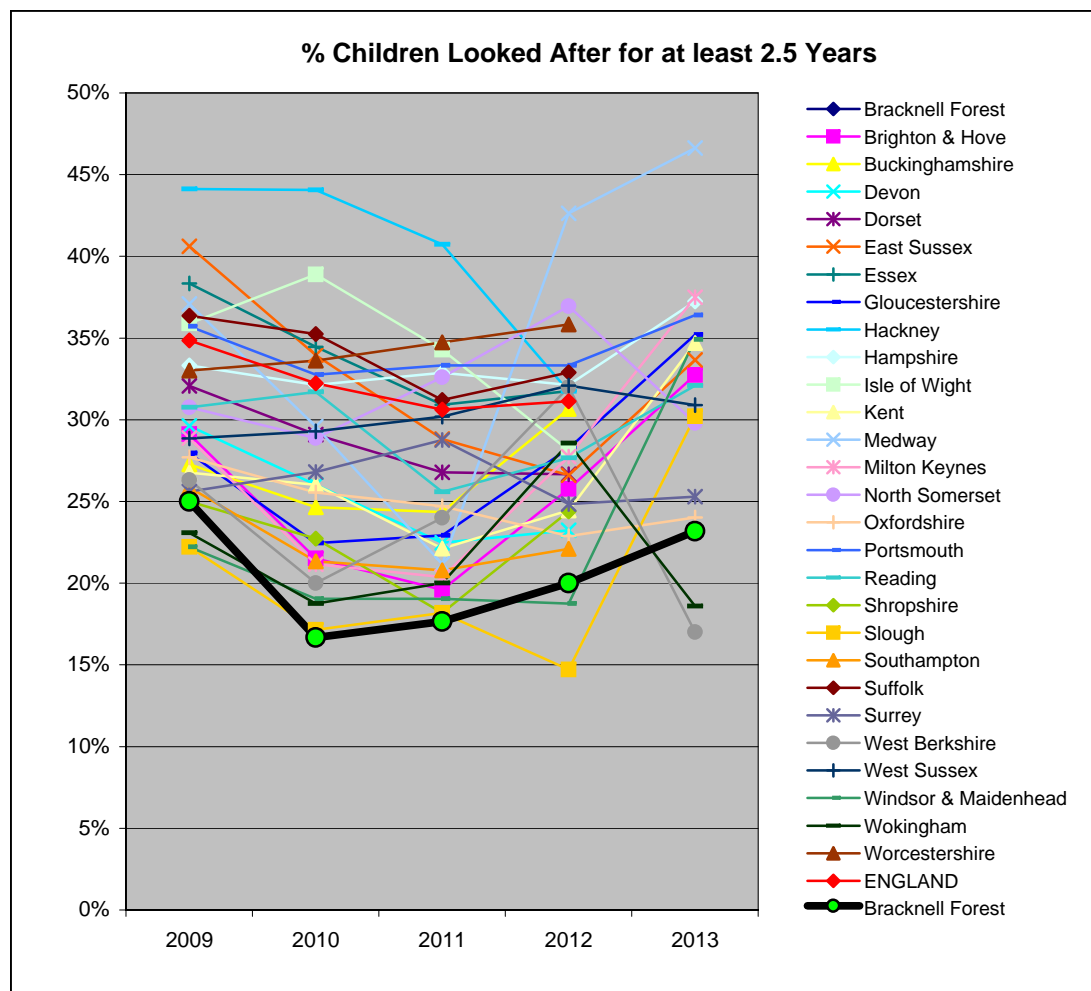

**Percentage of Pupils who attend a Secondary school that has been rated Good or Outstanding by Ofsted**

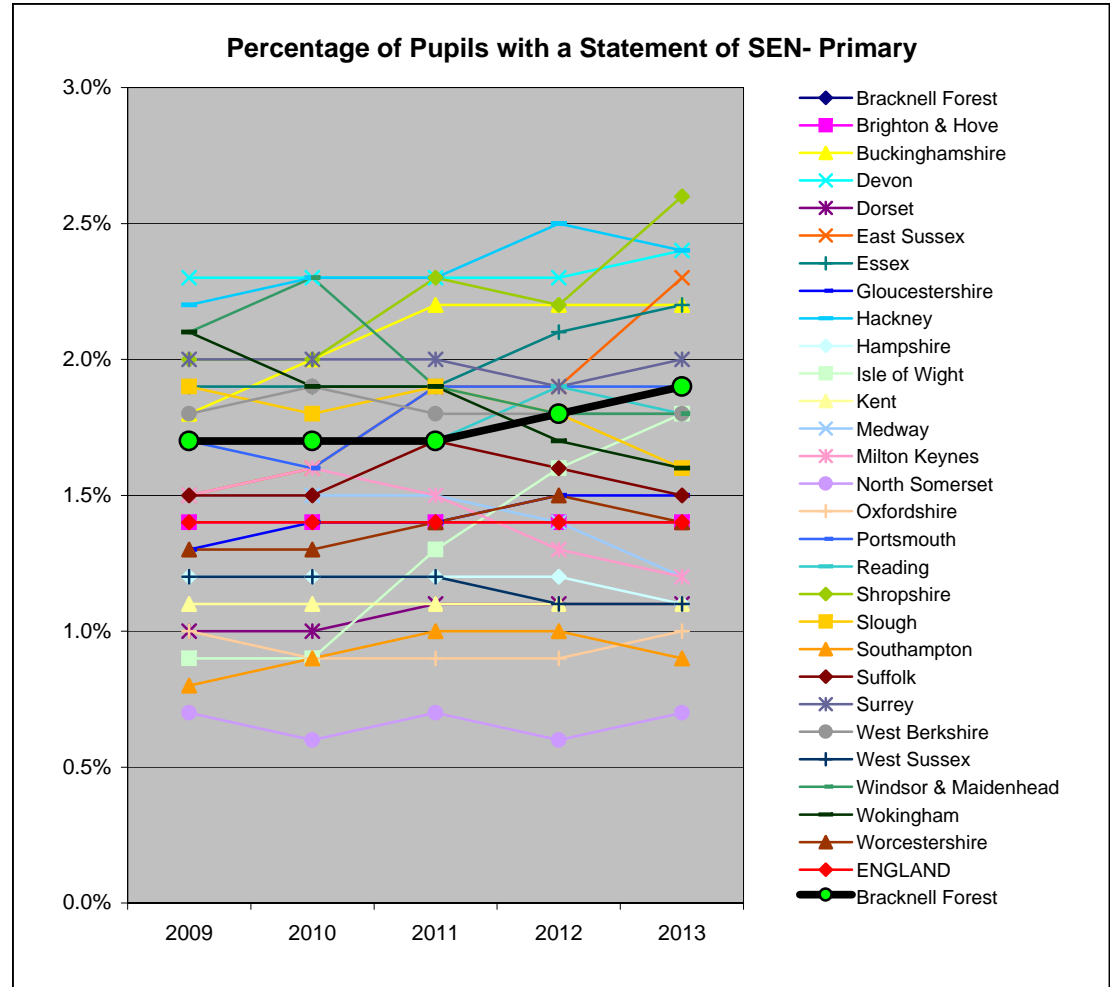

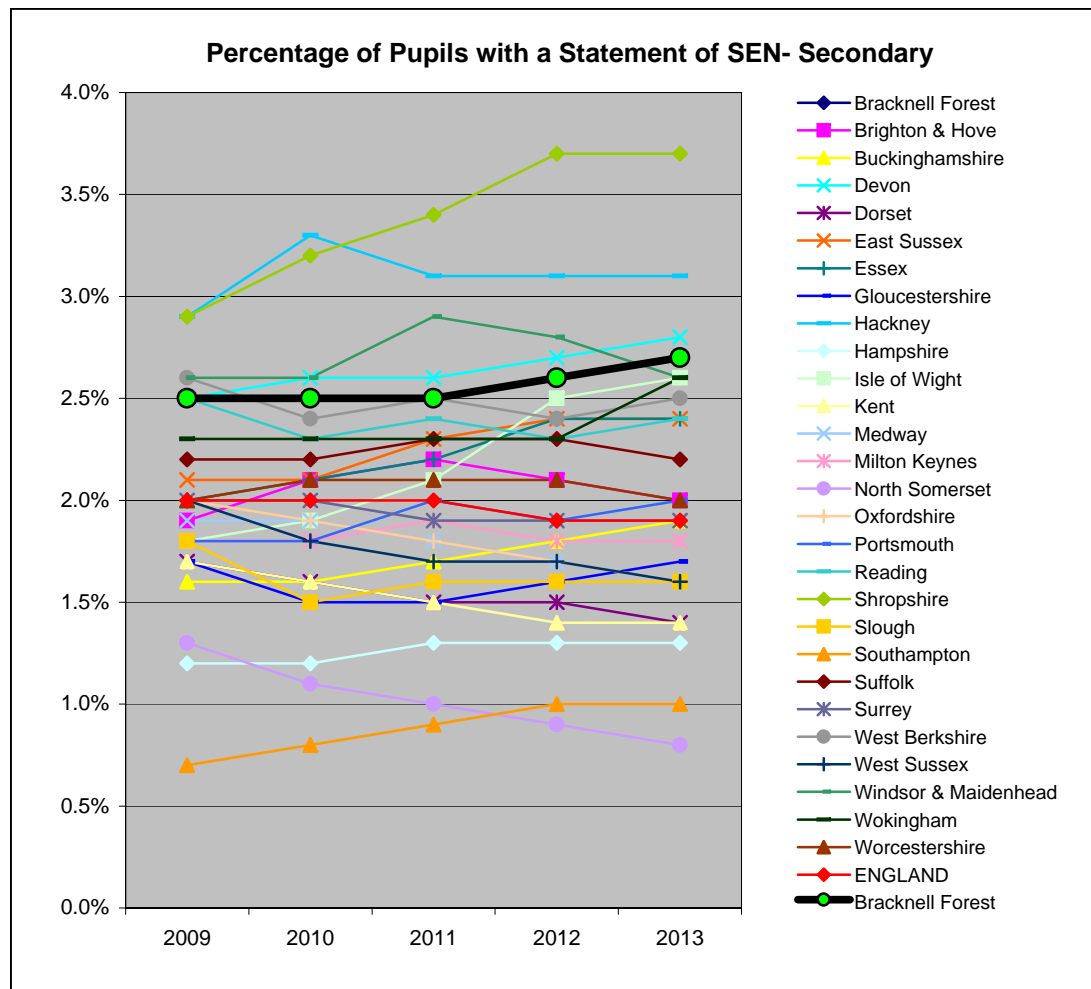
