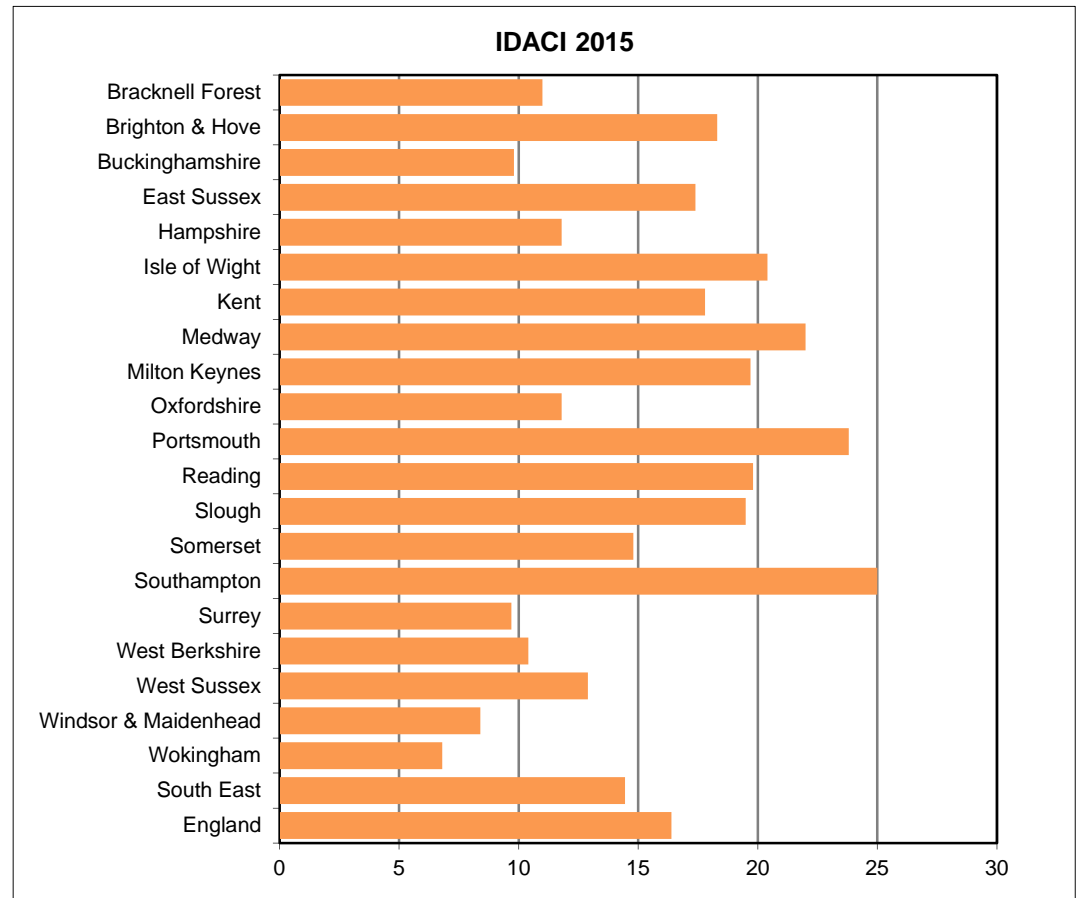
### IDACI

Percentage change in Number of Children subject to an Initial CP Conference 2012-2015

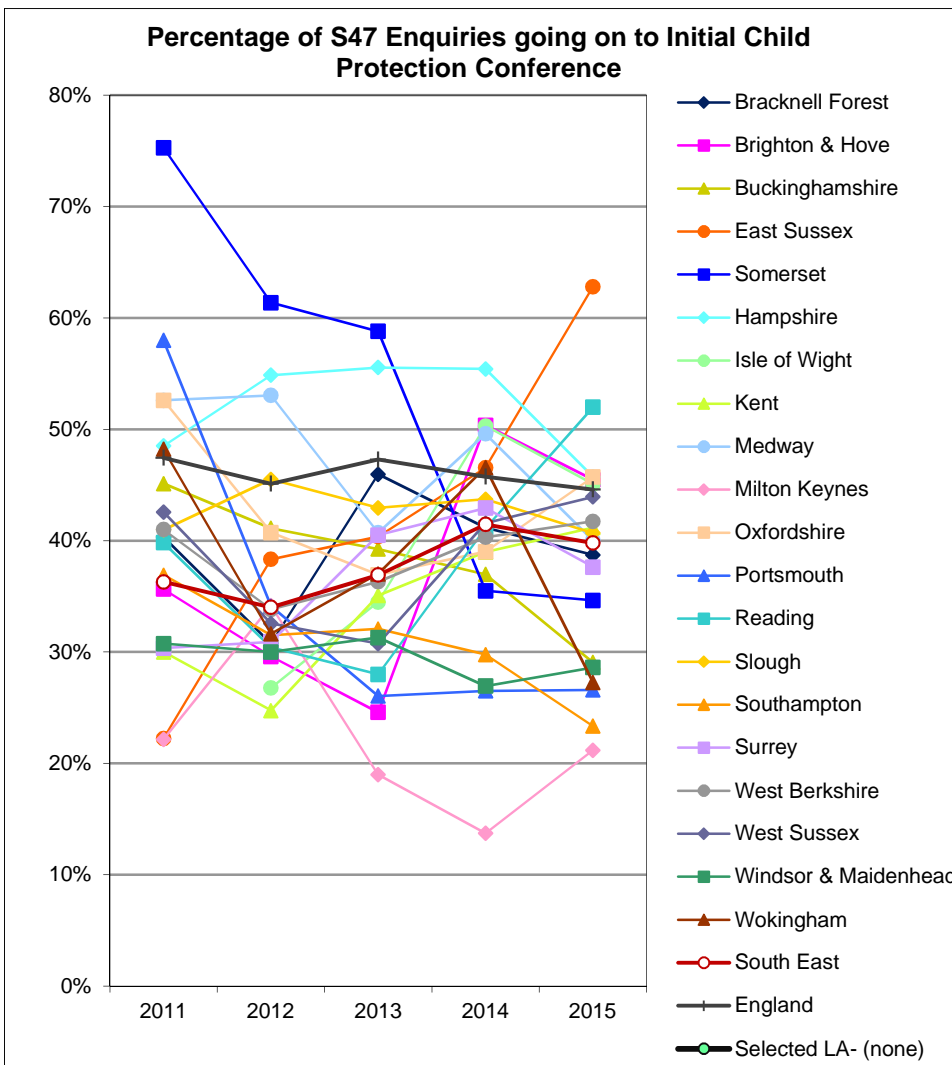


Distance from Expected Rate of Children subject to an Initial CP Conference



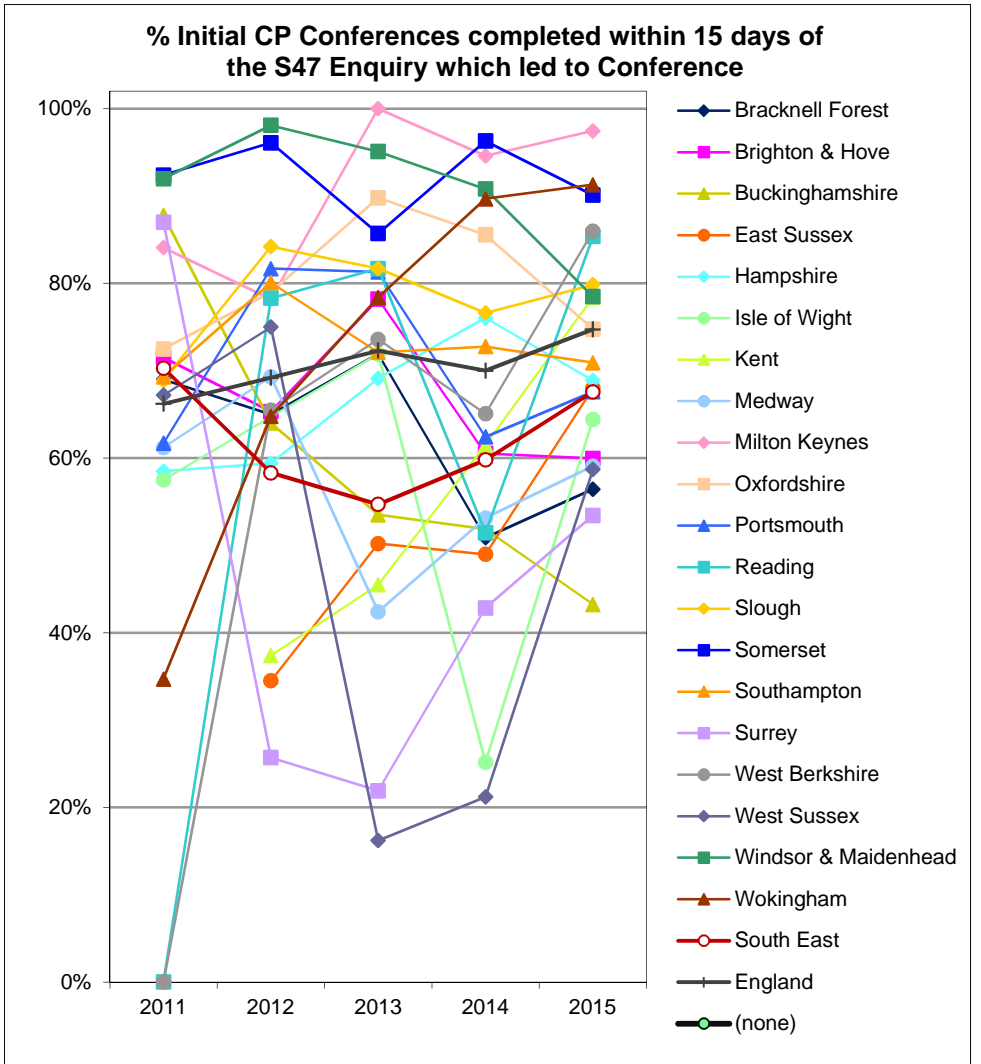

Percentage change in Number of Children subject to a Child Protection Plan 2012-2015

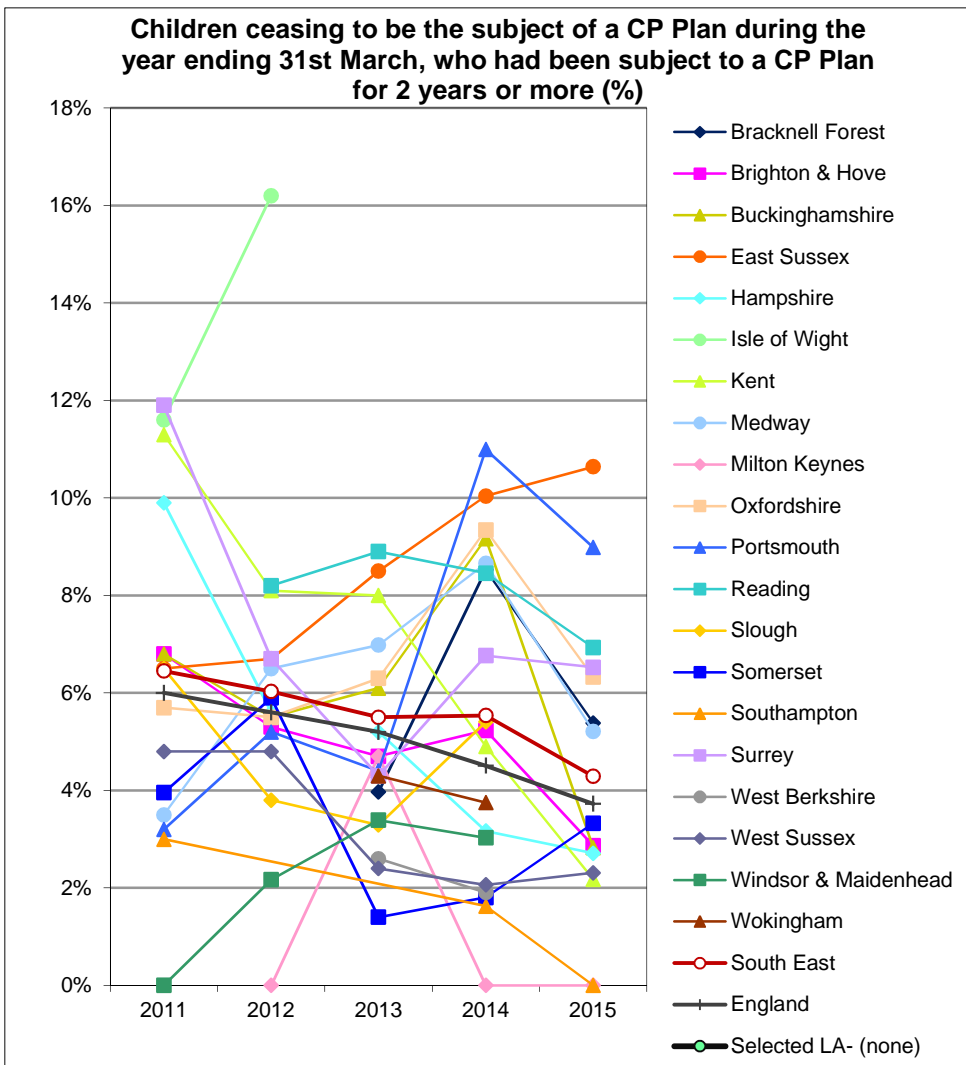


Distance from Expected Rate of Children subject to a Child Protection Plan



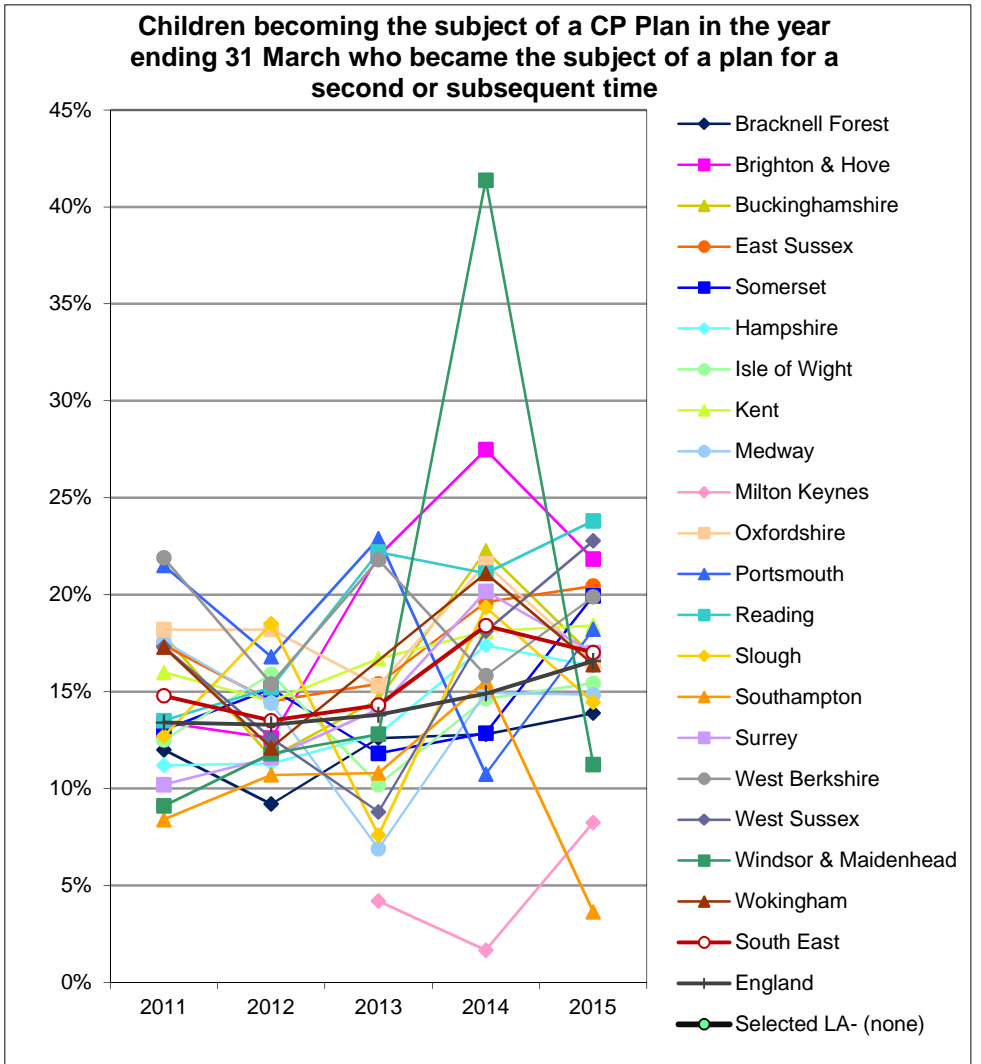
