1. DfE:

- A curriculum and assessment review has been launched and there will be a call for evidence from September with national roadshows and be led by EEF CEO Prof Becky Francis. The review is tasked to make recommendations for a broad, inclusive and innovative curriculum for Ks1 to KS5, building on foundation learning in English, writing and maths.

- Final, validated data about exclusions and suspensions for 2022-23. The rate of both exclusions and suspensions increased again and was at the highest rate since 2006-7 academic year. https://explore-education-statistics.service.gov.uk/find-statistics/suspensions-and-permanent-exclusions-in-england
- Ofsted has published its annual report and accounts. It highlights the challenging year it has had. The
 pause in inspections following the death of Ruth Perry mean it missed its target of inspections and it
 commits to start implementation of Big Listen reforms during 2024-25 academic year.

- Ofsted announces it plans to replace deep dive reviews in schools with ungraded inspections.
 These will look at groups of subjects together that are agreed in advance with heads from September.
 Schools previously graded good or outstanding receive ungraded inspections.

- Revised pupil number projections have been published. Although total numbers are still estimated to
 fall, the reductions in the numbers on are lower than previous estimates. For example secondary pupil
 numbers are expected to peak a year later in 2026, whilst the total number is expected to fall by over
 2 per cent, between 2024 and 2028, this is lower than previous estimates of 6 per cent.

- New statistical report about teacher development and retention, with a focus on engagement in the ECF and retention once completed and the numbers of teachers engaged in various NPQs. 2. Reports:

- Reading BC publishes its independent learning review from the tragic death of headteacher Ruth
 Perry. With regard to national recommendations, the report calls for greater clarity from government
 for the currently ambiguous role LAs find themselves with respect to maintained schools. For example,
 LAs employ maintained school staff, but, in reality, has few powers as an employer, these are instead
 deployed through governors; also LAs have a statutory duty to promote "high standards" but rely on
 maintained schools choosing to de-delegate part of their budgets back to the LA to fund monitoring

- LGA and CCN publish their report on developing a sustainable system for SEND. Despite the increasing investment and with 140% in the number of children with an EHCP, outcomes and attainment for children with SEND have not improved over the past 10 years. Among the recommendations are a greater focus on inclusion and clearer national definitions, including to inform needs assessments, plus statutory Local Inclusion Partnerships and local Destinations Services mandated to ensure effective transition to adult services. https://www.countycouncilsnetwork.org.uk/educational-outcomes-for-send-pupils-have-failed-to-improve-over-the-last-decade-despite-costs-of-these-services-trebling-new-independent-report-reveals/
- Strategies for achieving improved school attendance. The report highlights the importance of the start
 of the academic year and that 'sense of belonging' is vital for students at risk of absences. For
 example, over 80% of pupils indicated they were aware of the consequences of skipping lessons. A
 much smaller proportion felt that their teachers or school cared when they missed school. Also
 attendance is not a discrete issue and is closely linked to quality of teaching and areas such as reading,
 so leaders should work to make attendance everyone's issue.

- The Local Government Ombudsman's annual report for 2023-24. Education cases are its largest category of work and these are dominated by complaints in connection with SEND and LGO found failing from LAs in 92% of these. https://www.lgo.org.uk/assets/attach/6627/Annual-Review-of-Local-Government-Complaints-2023-24.pdf

3. Research

A research review, commissioned by the EEF, aims to enhance understanding of current writing teaching practices in England's primary and secondary state schools. It examines the challenges teachers and school leaders face and identifies well-established and valued approaches and methodologies. Of particular note is the evidence that secondary school teachers report a significant challenge was a lack of pupil motivation, with 25% citing this issue.

- A new Education Bill was featured in the King's Speech with proposals likely to include a register of
 children not in school, requirement for all schools to follow the National Curriculum and giving powers
 to Ofsted to inspect academy trusts. https://schoolsweek.co.uk/labour-education-bill-to-feature-in-kings-speech/
- Education secretary Bridget Phillipson will co-lead a new ministerial taskforce to help develop a child poverty strategy, with DWP SofS Liz Kendall. This sits alongside the new Government's commitment to a child well-being bill in the King's Speech. Included in the child wellbeing bill's proposals are a requirement that all schools cooperate with the LA on school admissions, SEND inclusion, and place planning, and giving LAs greater powers to help them deliver their functions on school admissions and ensure admissions decisions account for the needs for communities. - Informative analysis of differences in levels of school absences between the same pupil in year 6 and then in year 7, comparing those with a disadvantaged background (FSM6) and their peers. Levels of absence disproportionately increase in year 7 for those FSM6. Many following a similar pattern to year 6, hence the importance of information sharing between primary and secondary schools.

- Sir Kevan Collins is appointed as schools standards adviser by the new Government and as a non-exec director at the DfE. The Dept will also bring SEND and AP under its schools group to support its aim for improved inclusion in mainstream schools. https://schoolsweek.co.uk/sir-kevan-collins-joins-the-dfe-board/
- Headline, national KS2 SATs data published which shows a small increase in performance in most tests
 as compared with 2022-23, with 61% achieving the national benchmark (up from 60%). Attainment is
 still below levels that were achieved pre-covid. https://schoolsweek.co.uk/key-stage-2-sats-2024-slight-improvement-in-reading-and-writing/
- Calls for the last government's draft changes to RSHE to be withdrawn and the consultation ended.
 Organisations highlight that the draft changes risk leaving children more vulnerable to sexual
